



St. Bernardine of Siena School 2022-2023 Tuition Rates

Updated 6/29/22 – updates in green

Re-Registration Fee: \$500 *non-refundable* fee per child.

- **\$100 discount** if re-registration is paid by March 25, 2022.
- **Re-registration fee is \$500** after March 25th and due by April 27, 2022.
- **If registrations are not received by April 27th, our Waiting List will open to incoming applicants.**
- There will be a **\$50 late registration fee** for any registrations received after April 27th, space permitting.

Re-Registration Fee includes all supplies and books.

Tuition includes technology fee, minimum of one field trip per class, and basic sports fees.

DISCOUNTED RATE

The **discounted rate** is based on Mass attendance using the parish envelope at least 75% of the year for a minimum of 38 weeks based on envelope count from **January 1, 2021 through December 31, 2021**. **This has continued to roll-over from the 2019-2020 school year.** Families received credit for one envelope per week.

For the **2023-2024 school year**, the discounted/in-parish rate will be based on weekly Mass attendance and a possible suggested donation to St. Bernardine of Siena Parish from June 1, 2022 through June 30, 2023.

FUNDRAISING REQUIREMENTS

1. Each family has the following minimum fundraising requirement:
 - One Child: \$ 550
 - Two Children: \$ 650
 - Three Children: \$ 750
 - Four Children: \$ 850

2. The following fundraisers or direct payment will be accepted for this commitment:
 - ✓ **Parish Festival** 50% of pre-sale tickets and raffle, 50% of sponsorship

 - ✓ **Silent & Online Auction(s)** 100% for gift card donations, 50% for certificates for services/completed baskets

 - ✓ **Saber-Thon** 100% of sponsorship, 50% of raffle tickets

 - ✓ **Spring Event** 50% of ticket sales, 100% of sponsorship

 - ✓ **Golf Tournament** 50% of entries, 100% of sponsorship and raffle tickets

PARENT SERVICE HOURS

- 40 hours of service per family – Service directly to the school and **parish service that is pre-approved by the principal.**

- **\$50 per hour** will be assessed for unfulfilled service hours. Unfulfilled Festival hours will be billed at **\$100 per hour.**

- **A minimum of 6 hours must be completed at the Festival.** Remaining hours can be completed by additional hours at the Festival or any school or pre-approved parish events of your choice.

- **There is no limit to the maximum hours you can complete at any one event or activity.**

TUITION ASSISTANCE

St. Bernardine of Siena School has several opportunities for tuition assistance available to families.

- **Parish Tuition Assistance:** Families with regular Sunday Mass attendance who actively participate in St. Bernardine of Siena Parish may apply for parish tuition assistance. Completed application forms and tax documentation must be submitted. Members of the Parish Finance Council will review applications and determine the amount of assistance that will be granted. Families must reapply for tuition assistance annually.

- **Catholic Education Foundation (CEF):** Any family may apply for this grant. Families must complete the Archdiocesan forms and meet the qualifications (below) of the Catholic Education Foundation.

FY2023 FINANCIAL ELIGIBILITY GUIDELINES

A student from a household with a total income at or below the following levels is eligible to apply for a Tuition Assistance Award from the Catholic Education Foundation (CEF).

CEF defines a **household** as all individuals living together in the same dwelling who share expenses for rent, utilities, food, clothing, and other necessities. A **one-member household** is a student who is his/her sole support, such as an institutionalized minor or adult. A foster child is only considered a one-member household if the welfare/placement agency maintains legal responsibility for the child.

DAY CARE PROGRAM RATES – 2022-2023

MORNING DAY CARE [Monday-Friday – 7:00-7:30 a.m.]

The full-time monthly rate will be a fixed rate:

- \$60 per month for 1 child (\$15 per week)
- \$65 per month for 2 children (\$16.25 per week)
- \$70 per month for 3 children (\$17.50 per week)
- \$75 per month for 4 children (\$18.75 per week)

The daily rate for **any** portion of time between 7:00-7:30 will be \$5 per day (not to exceed full-time rate).

AFTER SCHOOL DAY CARE [Monday-Thursday – 2:45-6:00 p.m. / Friday – 12:45-6:00 p.m.]

Full-Time

- \$200 per month for 1 child
- \$250 per month for 2 children
- \$300 per month for 3 children
- \$350 per month for 4 children

Part-Time

- The daily rate for **any** portion of time until 6:00 p.m. will be billed at the part-time rate, \$15 per day.
- \$15 per day **per child** billed at the beginning of the following month (not to exceed the full-time rate).

There will be a \$1.00 per minute charge if child is picked up after 6:00 p.m.

Note: Day Care rates for August and June are charged \$15 per day, not to exceed the full-time rate. Day Care for December is charged as a full-time rate.

Day Care charges will be added to your FACTS account. **All families regularly using Day Care must be registered in FACTS.**

TUITION PAYMENT INFORMATION

Below is the tuition information for our 2022-2023 school year. You have the following options to choose from.

Option 1 – Payment in Full

This Single payment, in cash or check (made payable to St. Bernardine School), is due by **August 1, 2022.**

All monthly payment plans are through FACTS with the options listed below:

Option 2 – 10 Month Plan

Payments begin in September – end in June

Option 3 – 11 Month Plan

Payments begin in August – end in June

Option 4 – 12 Month Plan

Payments begin in July – end in June

Please note that the only option for families who do not enroll in FACTS is the one-time payment in full. We do not accept partial payments.

*If you are a returning parent and are already registered in the FACTS program, your agreement plan will roll over - **you do not need to re-enroll; unless you have a graduate in the Class of 2022. If you would like to change your current plan agreement, you may log in to your FACTS account and make those changes. Changes to pull dates and number of monthly payments can be completed by the account holder.***

For all our new users enrolling in FACTS for tuition and/or day care, you need to register with FACTS by June 30, 2022.
